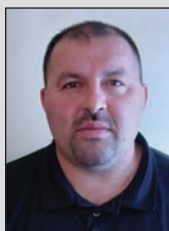


CAMP STAFF

Drago began his pro soccer career at age 17 in Yugoslavia with the Red Star Belgrade team. Later, he was drafted by FC Ruoan in France and also played with Panahikel in Athens, Greece. In the US, Drago played with the San Diego Sockers, Tulsa Tornados, Detroit Rockets, Rochester Lances and Columbus Capitals in the NASL (North American Soccer League). Drago spent the 1997 season as the Head coach of the Columbus Invaders in the National Professional Soccer League (NPSL). In 1998, Drago became the director of coaching and President of Lake Forest United Soccer Club. In 2008 Drago signed on with TCSA to head up their new Premier Soccer program.



Vlatko Minic
DEFENSE COORDINATOR

Vlatko Minic was an assistant coach for four seasons at UW-Parkside, where he helped guide the program to a 40-7-7 record, as well as two Conference Championships and two NCAA appearances. In high school he earned three First Team All-Conference nominations and took his skills to Madison where he went on to be a part of the building block that saw the Badgers win the National Championship in 1995. His professional playing career included stints with the Milwaukee Rampage and the Pittsburgh Stingers. In 2004, Vlatko Co-Founded the Red Star SC and is currently coaching there today.

As a native of Yugoslavia, Joe Raduka was a member of the Red Star Soccer Club and helped secure the Eurocup title for his club in 1971. In 1978, Joe came to the United States to play with the Oakland Stompers, Edmonton Drillers and San Jose Earthquakes. Joe started his teaching career in 1987 with the founding of a youth soccer club called Cleveland United. There he has been the recipient of numerous awards including National Coach of the Year for Youth Boys from the National Soccer Coaches Association of America.
